In recent years, for example, we have assisted a client with multiple financings of a major mixed-use retail/entertainment and office development located in suburban Columbus, Ohio. In addition, our lawyers recently represented the developer of the Union Gospel Press project in Cleveland, Ohio, an urban redevelopment project that will include the rehabilitation and adaptive re-use of a 178,000 square foot complex of historic buildings in the Cleveland Tremont Historic District, resulting in the development of 77 luxury, market-rate residential apartments and 26 extended-stay furnished corporate units. That project was financed in part through loans and equity investment resulting from the availability of both New Markets Tax Credits and Historic Tax Credits, and in part through traditional commercial financing.
