Congressman Dave Hobson Joins Vorys

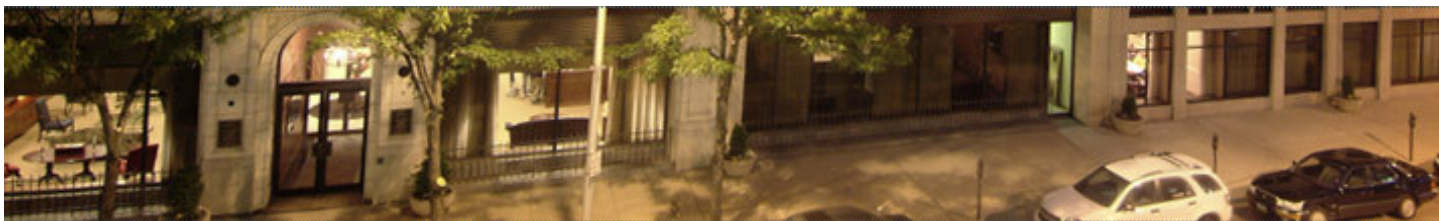
