As a partner in a Washington, D.C. law firm, Mr. Dill lobbied for diverse clients in the energy, financial services, energy, entertainment, human services and gambling fields. As the chief lobbyist for the american retail industry, he helped lead the successful national fight to defeat President Clinton's health care proposal.

From 1995-1998, Mr. Dill was director of economic development for the State of Colorado, the state's top business official and a member of the governor's cabinet. In 1998, Mr. Dill formed his own Denver-based government affairs and political consulting company representing Kerr-McGee Corporation, Lockheed Martin and Dolan Media among other local and national clients. From 2004 – 2010, Mr. Dill served as president/CEO of the Credit Union Associations of Wyoming and Colorado.

Mr. Dill opened Chesapeake's Rockies office in Denver in 2010 and assumed his current role at Chesapeake's corporate headquarters in Oklahoma City in September, 2013.

#### **Ned Hill**

Professor, The Ohio State University

Dr. Edward [Ned] Hill teaches economic development policy, public policy and public finance in both the Glenn College and the City and Regional Planning section in the College of Engineering's Knowlton School of Architecture. Before coming to Ohio State, Dr. Hill was dean of the Levin College of Urban Affairs at Cleveland State University for eight years and was Professor and Distinguished Professor of Economic Development.

He serves as nonresident senior fellow of The Brookings Institution, where he is affiliated with the Metropolitan Policy Program. He was chair of the Advisory Board of the National Institute of Standards and Technology's (NIST) Manufacturing Extension Partnership (MEP) from 2007 until 2010. His appointment to the Board ended in April 2014, making him the board's longest serving member.

He has edited Economic Development Quarterly and is a member of the editorial board of the Journal of the American Planning Association. His latest co-authored book, Economic Adversity and Regional Economic Resilience, is expected to be published by Cornell University Press in 2016.

Crain's Cleveland Business recognized Hill's work in 2012 when he was listed in its Who's Who, 150, Names to Know in Northeast Ohio. Hill is listed in Crain's 2014 Power 150. Gov. Taft appointed him to Ohio's Urban Revitalization Task Force, Gov. Strickland named him to the Automotive Industry Support Council, Gov. Kasich placed Dr. Hill on the state's manufacturing task force, and former Speaker of the Ohio House of Representatives Bill Batchelder appointed him to the Cooperative Education Advisory Board of the Ohio Board of Regents.

Dr. Hill holds a doctoral degree in economics, urban and regional planning, a master's degree in city planning from the Massachusetts Institute of Technology and a bachelor's degree in economics and urban studies from the University of Pennsylvania.

Asim Z. Haque was appointed to the Public Utilities Commission of Ohio by Governor John R. Kasich in 2013, and reappointed by Gov. Kasich to serve a second term in 2016.

Chairman Haque, an attorney, began his professional career at a large general practice firm in Columbus where he represented a broad spectrum of clients in energy and utility matters. He went on to serve as internal legal counsel for a global auto manufacturer, a role he held immediately prior to his appointment to the Commission.

Chairman Haque has represented Ohio's interests in energy and utility matters within the state, nationally and internationally. He has testified before members of the Ohio General Assembly, the Federal Energy Regulatory Commission, and has educated regulators abroad through formal partnerships with the U.S. Agency for International Development.
