Kathleen is skilled in all aspects of real estate closings, including acquisition financing, new construction, refinancing, nursing home portfolio transactions and master leases.

Prior to joining Vorys, Kathleen spent more than 20 years as an attorney with the U.S. Department of Housing and Urban Development (HUD) in the Washington D.C. headquarters Office of General Counsel (OGC). She worked as a trial attorney in the office of litigation, attorney-advisor in OGC's single family mortgage division, and senior attorney in OGC's multifamily mortgage division.

Career highlights include:
