- I-71 North to I-76/
- Take the I-76/US-224 exit towards AKRON/LODI, (#209)  
Continue towards Akron
- Merge on I-76 East
- Take the I-76 East exit towards Akron
- Take the I-76 East/I-77 South exit towards Akron
- Take the OH-59 East exit towards Downtown, (#21C)
- Exit at Cascade Parking ramp
- Travel through two traffic lights to a stop sign at Mill St.
- Turn right on Mill St .and a right into the Cascade Parking garage
- Huntington Building (*formerly First National Tower*) is on the corner of Mill St. and South Main St.

### FROM CLEVELAND

- Take I-77 S towards Akron
- Continue on I-76 E/I-77 S
- Take the OH-59 E exit towards Downtown (#21C)
- Exit at Cascade Parking ramp
- Travel through two traffic lights to a stop sign at Mill St.
- Turn right on Mill St. and a right into the Cascade Parking garage
- Huntington Building (*formerly First National Tower*) is on the corner of Mill St. and South Main St.

### FROM MANSFIELD

- Take US-30 E towards Wooster
- Take I-71 N towards Cleveland
- Take the I-76/US-224 exit towards Akron/Lodi (#209)  
Continue towards Akron
- Merge on I-76 E
- Take the I-76 E exit towards Akron
- Take the I-76 E/I-77 S exit towards Akron
- Take the OH-59 E exit towards Downtown (#21C)
- Exit at Cascade Parking ramp
- Travel through two traffic lights to a stop sign at Mill St.
