## Ohio Announces Opening Dates For Salons and Barbershops

In his regular press conference on Thursday, May 7, 2020, Governor Mike DeWine announced the first stage of Ohio's plan to reopen hair salons, day spas, nail salons, barbershops and tanning facilities on May 15, 2020. ### Facility Requirements and Recommendations

Businesses are required to maintain a minimum safe social distance of 6 feet between people —excluding an employee providing services to a client. Where this is not possible, the business must install a physical barrier. Businesses must post signage to this effect in conspicuous places in their establishments and establish new maximum capacity based on social distancing requirements. High-contact surfaces must be cleaned every hour, chairs and equipment must be cleaned after each use, and merchandise must be cleaned before stocking. All self-service refreshment and client testing of products must be discontinued. Items in waiting areas must either be disinfected regularly or, where that is not possible (e.g, magazines), must be discarded.

Businesses are advised, but not required, to close once a week for deep cleaning and adopt contact-less payment methods.

### Employee Requirements and Recommendations

Employees must wear facial coverings, subject to certain exceptions. Employees are required to conduct daily symptom assessments and stay home if symptomatic. Employees are further required to wash their hands frequently, to wear single-use gloves, and to dispose of those and other single-use items between customers and/or tasks.

Employees are also encouraged, but not required, to wear eye protection at all times.

## Customer Requirements and Recommendations

Customers are required to maintain safe social distancing at all times except between themselves and the employee with whom they are working. Customer entry must be staggered so as not to have groups of people queued at the door or check-in desk in violation of social distancing requirements. Customers may not enter with a guest (unless that individual is a caregiver) and may not enter if symptomatic. Businesses must provide hand sanitizers in all high-contact locations for customer use. Additionally, businesses must specify hours for high-risk populations.

Businesses may require customers to wear a mask at all times at their discretion and are encouraged to provide their services by appointment only.
